

Note :

1. "The Ad-hoc fees as declared above shall be applicable to respective new courses started by the Unaided Institutions from the academic year 2024-2025.
2. The Ad-hoc fees to be charged to students admitted in the academic year 2024-2025 by the newly started courses/colleges shall be the maximum fees to be charged by the institutions.
3. The Ad-hoc fees to be charged to students subject to the finalization of fees by the Fees Regulating Authority in respect of such course or courses.
4. If the fees determined and finally approved by the Authority found to be less than the Ad-hoc fees charged and collected by the Institute then the difference in the amount of fees to be refunded to such students by the Institute.
5. If the fees determined and finally approved by the Authority found to be more than the Ad-hoc fees charged and collected from the students then the Institute will be entitled to claim the difference in the amount from such students subject to such order to be passed by the Authority.
6. The Institution shall be under obligation to submit the online proposal with the requisite documents as provided u/s. 14(1)(a) of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015, to approve the fees charged as Ad-hoc fees and further to approve the fees for the academic year 2025-2026 or 2026-2027 as the case may be.
7. No Institution shall charge the fees in any form over and above the Ad-hoc fees declared by the Fees Regulating Authority."

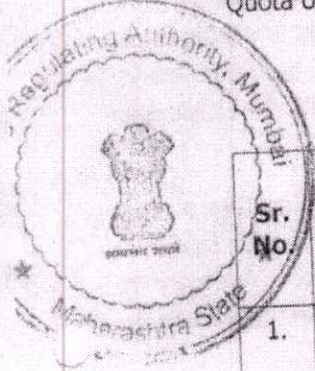
The Authority is receiving complaints against the Institutes/ Colleges alleging demand of fees more than the fees prescribed for admission under Management/ Institutional Quota or N.R.I Quota.

The Commissioner-cum-Competent Authority, State Entrance Test Cell, State of Maharashtra has sent a letter & requested the Authority to publish the course wise maximum fees that can be charged by the Unaided Institutes/Colleges from the students securing admission under Management/Institutional Quota or NRI Quota.

In view of the complaints received and request received from the Commissioner-cum-Competent Authority, State Entrance Test Cell, State of Maharashtra, the course-wise maximum fees which can be charged from the students securing admission under Management/Institutional Quota or N.R.I Quota by the Institutes/Colleges is notified as under:-

All the Institutes/Colleges are directed to take note that demanding or charging fees more than the fees prescribed by the Authority amounts to violation of provision of the Maharashtra Unaided Private Professional Educational Institutions (Regulations of Admissions and Fees) Act, 2015 (hereinafter referred to as 'said Act 2015') and liable for penal action as provided u/s. 20 of the said Act 2015. In order to avoid the penal consequences, the Institutes/Colleges are directed not to indulged into any act of demanding, charging or collecting fees more than the fees prescribed by the Authority from the regular students as well as students admitted under Institutional or N.R.I. Quota. The breach of provision would be dealt seriously and appropriate action shall be taken against the Institutions/Colleges violating the provision of the said Act of 2015.

If any demand of fees more than the fees prescribed, is made by the Institute or any Institute has charged the fees more than the fees prescribed by the Authority then such students or their parents are requested to lodge complaint in the office of Fees Regulating Authority in writing or may send complaint to Authority through Grievance Portal i.e. www.mahafr.org or by sending complaint through e-mail id i.e. fra.govmh@gmail.com.


The Institutes/colleges are further directed to take note that as provided u/s. 14 (4) of said Act of 2015 the course wise fees approved by the Fees Regulating Authority must be displayed on its notice board as well as website of the Institutes/colleges in Marathi and English and incase of Linguistic Minority Institution the fees shall also be displayed in the language of the Minority to which such Institutions belongs.

As provided u/s. 14(5) of the said Act of 2015 no Institution is entitled to collect the fees more than one year fee from the candidate in the academic year and collection of fees of more than one year in an academic year shall be construed as collection of capitation fee. The act of demanding fees or collecting the fees of more than one year from the candidate in an academic year liable for penal consequence.

All concerned to take note accordingly.
